EXERCISE REGULATION

The regulation of the area equipped camper Brezza di Mare is set up to ensure everyone a uniform, orderly, peaceful and peaceful use of the structure.

1. Acceptance

The stay in the area implies the total acceptance of these Regulations. Failure to comply with the Regulations and with the other provisions of the Direction imply the removal of the offender from the field and the related reporting of the fact to all national and international tourist organizations, unless otherwise reported to the Public Authorities in case the non-compliance may eventually constitute offense.

All the specific indications shown on the signs in the area must also be respected.

2. Area

The parking area is owned by the Società Brezza di Mare srls. For problems you can contact directly the bar inside the area or call the following telephone number 3925485629. The company is not responsible for the removal of goods, valuables or other goods or damage caused by other users.

The area, designed to meet the needs of traveling tourists is not bookable, is intended exclusively for campers (motor homes) and therefore it is forbidden to use users with caravans, carts, tents and other accommodation facilities.

Near the secondary entrance there is a wastewater discharge system, a potable water dispenser and containers for the separate collection of waste; the access system is automated and video-monitored.

The motorhome is required to occupy only the area reserved for it, as defined on the ground. Each vehicle is enabled to use only one connection to electricity.

If the area is complete, there is the possibility to use, at a reduced rate, only the loading / unloading at the times allowed and indicated in the signs in the area.

Any time must be avoided behavior, noisy activities and use of equipment that cause disturbance. Respect the hours of silence from 14:00 to 16:00 and from 24:00 to 08:30.

3. Water

At each pitch there is a water connection. In Puglia, water is a precious commodity. We pray to the Dear Guests to take special care of it, avoiding any form of waste. It is absolutely forbidden to use water for improper use. The amount of water that can be taken is proportional to the capacity of the tanks of the camper. It is absolutely forbidden to use water to wash the camper, for personal use (eg showers.), and for others uses other than loading water into the tank.

4. Dogs and other animals

Dogs must always be kept on a leash. The companions have the obligation to collect the needs of their animals. Any damage caused to third parties by animals is the responsibility of the companion.

5. Prohibitions

It is absolutely forbidden to light fires, you can use the barbecues made available to guests.

It is also forbidden to play football or practice any other activity, potentially capable of causing damage to Third. Within the area it will be forbidden to park or park cars, any exceptions must be authorized by the company in compliance with the safety conditions of the guests.
